### CARE OF DOG WHILE ON PREMISES

### CERTIFICATE OF VACCINATIONS

All dogs must wear current rabies vaccination tags/certificate from a licensed veterinarian , attached to their collar at all times while on the premises. Tag must include the dog's name, description, age, date and type of vaccination. Dogs must be neutered / spayed.

### DAMAGES

Any damages to the premises or guests property caused by the dog must be immediately repaired, cleaned and or replaced at owner/tenants expense (including but not limited to urine stains, broken windows, or scratched /chewed structures, and includes cars on the premises. Owner will supply bags for disposing of excrement and it must be picked up immediately.

Any injuries sustained by any person(s) by the named dog are the sole responsibility of the owners/ tenants. Wellers will not be held liable for any injuries or damages sustained by the dog.
